#### **Payment Methods**

All parents/carers will be given the option to pay in instalments.

To further assist parents with payments, four options have been developed:

- D. Alternative payment arrangements please call office to discuss other available options

#### **Refunds**

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's <u>Parent Payment Policy</u> or the <u>Financial Help for Families Policy</u>. School Council has the responsibility to ensure there is a fair and equitable refund system in place following payment for Camps/Excursions/Incursions and to ensure parents provide information to the school in a timely manner.

The DET Student Resource Package (SRP) helps meet staff salaries and most operational costs, it does not cover contingencies, Enriched Learning Programs and planned improvements within the school. Voluntary parent financial contributions help bridge the gap between DET SRP and budgeted annual expenditures. #### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



#### SCHOOL PROCESSES
